Thursday 26 December 2024 - Submissions open

Friday 28 February 2025 - Deadline for submission of application forms and questions

Early March 2025 - Announcement of selection and screening results

4. Eligibility:

Applicants must fulfil all of the following requirements:

(1) Applicants must have knowledge and skills in film production and an understanding of the Expo's philosophy.

(2)Not a person listed in any of the items in Article 32, paragraph 1, item 1, of the Act on the Prevention of Unjust Acts by Organised Crime Group Members (Act No. 77 of 1991).

5. Submission Procedure

Submission Procedure

- (1) Applicants may be either individuals or organisations and may submit multiple videos.
- (2) Distribution of Submission Guidelines and acceptance of submission documents.
 - A) Submission Guidelines Distribution PeriodFrom Thursday, 26 December 2024 to 17:00 on Friday, 28 February 2025.
 - B) Method of Distribution

Download from the Association's website (The documents will not be distributed by post).

C) Acceptance Period

From Thursday, 26 December to 17:00 Friday, 28 February 2025

D) Where to Submit

Compile the four types of material required as set out in (3) into a single zip file and upload it via the following link:

E) Submission Method

The application form and video content must be submitted in a zip file.

F) Expenses

All costs of the submission shall be borne by the applicant.

- (3) Items required when submitting
 - A) Application Form (PowerPoint file)
 - B) Confidentiality Agreement (Word file)
 - C) Pledge of the Ordinance on the Elimination of Organised Crime Groups (Word file)
 - D) Video file (MP4 format)

*Note: The PowerPoint data for (a) and the signed PDF data for (b) and (c) must be prepared and submitted alongside the video file.

- (b) and (c) must be signed in both the Japanese and English versions.
- (4) Points to Note
- A) Return of Submission Documents

Submission documents and video files will not be returned for any reason.

The submission documents shall only be used for the purpose of screening the applicants for this project and shall not be used for any other purpose.

B) Incomplete Submission Documents
Incomplete applications may not be considered.

The selection committee will screen the films and decide which films will be shown on the EXPO VISION.
