1. Objective

With the cooperation of related organizations, the Association will establish basic plans for "environmental sanitation measures," "food sanitation measures," and "infectious disease control measures," and it will strive to maintain public health at Expo 2025 by implementing these measures comprehensively.

The Association will also set up the Site Sanitation Surveillance Center within the venue and work closely with the center, which is mainly run by Osaka City, to ensure proper sanitation management inside the venue.

2. Environmental Sanitation Measures

1. General provisions

Participants and the Association will make efforts to maintain sanitation inside the venue, ensure a clean and comfortable environment, and thereby protect the health of visitors and related workers.

In addition, laws and regulations on environmental sanitation must be observed.

2. Measures before the event

In order to ensure a sanitary environment in buildings, the Association will require building and facility managers to comply with laws and regulations on environmental sanitation and to conduct necessary advance investigations and take the necessary measures.

In addition, in consultation with governmental organizations, opportunities for group or individual guidance will be secured at the time of application for building confirmation, etc., and necessary matters will be shared with building and facility managers, etc.

Participants and the Association will also make efforts to design areas under their respective management in a manner that prevents the ingress of rats, disease-carrying insects, etc. and to take measures to prevent their occurrence, such as by taking measures to control and clean the area.

3. Measures to be taken during the Expo

Participants and the Association will comply with laws and regulations on environmental sanitation inside the areas under their respective management, and they will carry out necessary cleaning and other measures to maintain sanitation inside the venue and ensure a sanitary environment.

In addition, since the buildings within the venue are expected to be used by an unspecified

number of people, the Association will cooperate with governmental organizations in their monitoring and guidance in accordance with laws and regulations on environmental sanitation, and it will support governmental organizations and building and facility managers by attending on site inspections as necessary.

Furthermore, the Association will separately define procedures for the operations to control rats, disease-carrying insects, etc. and will establish a monitoring and inspection system during Expo 2025.

When health damage occurs that is presumed to be caused by bad environmental sanitation in buildings, etc., the Association will work with building and facility managers and governmental organizations to take necessary measures.

3. Food Sanitation Measures

1. General provisions

Food business operators and the Association will ensure food safety by preventing food poisoning and other food-related accidents within the venue, thereby protecting the health of visitors and related workers.

In addition, laws and regulations on food sanitation must be observed.

2. Facilities subject to food sanitation measures

The facilities covered by this basic plan include all food handling facilities (including their related facilities) within the venue.

3. Liaison and coordination with related organizations

The Association will communicate and coordinate with governmental organizations and endeavor to ensure smooth food sanitary management.

In the event of an outbreak of food poisoning, food handling facilities (including their related facilities) and the Association will cooperate with governmental organizations in conducting investigations into the outbreak of food poisoning and other operations so that they can be carried out smoothly.

The Association will also cooperate with related organizations in food monitoring guidance outside the venue before and during Expo 2025.

4. Voluntary food sanitation management system at facilities inside the venue

In order to prevent accidents such as food poisoning caused by food cooked, processed, or sold at the venue, it is essential that food business operators thoroughly implement voluntary food sanitation management.

To this end, the Association will take actions such as establishing voluntary

organizations for food business operators and will work with the Site Sanitation Surveillance Center to ensure thorough voluntary food sanitation management.

5. Food sanitation at facilities inside the venue

In order to thoroughly implement food sanitation management inside the venue, the Association will separately determine the necessary matters regarding food sanitation management in facilities inside the venue and sanitation management of employees.

6. Prevention of accidents caused by cooking outside the venue

The Association will also cooperate with related organizations in the event of accidents caused by food brought in from outside by visitors and related workers or food that has been cooked or manufactured outside the venue.

7. Raising awareness of food sanitation inside the venue

During Expo 2025, the Association will follow the food poisoning warnings issued by Osaka City and alert visitors and related workers at the venue, and it will work with related organizations to seize every opportunity to raise awareness of food sanitation.

4. Infectious Disease Control Measures

1. General provisions

Regarding infectious disease control measures, given that the event will be held for a long period of time and will attract many visitors not only from within Japan but also from overseas, the Association will take comprehensive measures for infectious disease prevention as stipulated by law, including environmental and food sanitation measures.

In addition, to combat infectious diseases, basic infection prevention measures will be thoroughly implemented inside the venue to prevent the spread of infection, and an information network will be established with the cooperation of related organizations during the event to protect the health of visitors and related workers by quick and appropriate responses.

2. Infectious disease control measures inside the venue

In order to prevent the spread of infectious diseases, the Association will encourage related workers to take proper health measures and provide sanitation education.

In addition, if there is concern about the spread of infectious diseases, we will request visitors and related workers to take necessary measures.

3. Measures to be taken in case of an infectious disease outbreak

The Association will cooperate with public health measures taken by governmental organizations and will establish a system to prepare for unforeseen circumstances, including providing medical relief and disinfecting the venue in the event of an infectious disease outbreak inside the venue.

In addition, the Association must comply with laws and regulations on infectious disease, including cooperation with governmental organizations, in conducting active epidemiological investigations.
